Instruction for Authors

Conference Proceedings

International Conference *Integrated Management of Environmental Resources* Stefan cel Mare University - Forestry Faculty of Suceava, Romania, November 3-4th, 2017

To ensure a convenient publication process, the authors are requested to follow these instructions. The submission of the full paper implies that it contains original work, and has not been published or submitted for publication anywhere else. The act of submission also infers the transfer of the copyright from the author to the publisher (*Suceava University Publishing House*). The authors will be contacted in order to submit a letter, in which it is clearly stated the originality of the paper, the release of copyright to Suceava *University Publishing House* and the content approval of all the authors. The authors are the only responsible for the entire content of the article. Before the publication, the paper will be reviewed by members of the scientific committee and a notification of acceptance will be send to the corresponding author.

Conditions

Document type: Microsoft Office - Word document (doc / docx)

Language: The papers have to be written in English (UK).

Abstract: The full paper should include an abstract of 200-300 words, providing information regarding the research objectives, materials and methods, results, discussion and conclusion.

Keywords: At the end of the abstract the authors should include 3-6 keywords for indexing purposes. **Extent**: The articles should not exceed 10 pages including abstracts and references. The minimal length is set to 4 pages (see instructions for the document format below).

Figures/illustrations: All the illustrations should be constantly titled and numbered and must be cited in the text. The accepted formats: TIFF, EPS, JPG, PNG with a high resolution (a minimum resolution of 300 DPI is required for photos and 500 DPI for graphs). All illustrations shave to be inserted in the text in the appropriate place, but also have to be delivered as distinct files. If the authors intend to use illustrations already published *they must acquire the permission of the original author and publisher and give full reference to the original work*. The illustrations will be printed in GRAYSCALE therefore appropriate colours should be chosen.

Tables: The tables must be as well titled and numbered consecutively and must be cited in the text.

Citations: References will be cited in the text as follows: (Bursuc, 2010), (Bursuc, 2010 a,b), (Bursuc and Meles, 2010). If the reference includes more than three authors the citation will take the form (Bursuc et al, 2010).

References: Authors are responsible for the accuracy of their references. All references must be listed alphabetically and cited in the text. The following examples illustrate the required format:

Names of the authors, Year of appearance. Title of the journal article. Publication name. Volume and issue,pages (e.g. 21(1) 23-36.

Name of the author, 2010, Title of the book. Publisher. City. Number of pages.

Bursuc, J., 2010, Forest Ecosystems. John Wiley & Sons, Chichester, p. 458.

Paper structure

The article should contain the **paper identification info** (paper title, name of the authors and their affiliation, e-mail for corresponding author, abstract and keywords) and the **paper main body**.

The paper main body should be organized under the following major headings, with each heading and subheading evidently defined:

- Introduction
- Materials and methods
- Results
- Discussion
- Conclusion
- Acknowledgments (when appropriate)
- References

Document format

Paper size: ISO B5 with normal margins (2.5 cm all around)

The text from the paper main body should be formatted in **2 columns** (0.4 cm between columns), **singled-spaced**.

Recommended fonts: Times New Roman

Font size and style:

Size 14 bold – for the title

Size 12 bold – for headings

Size 12 – for subheadings, authors' names

Size 11 – for the text from the paper main body

Size 10 – for affiliation, abstract, references, keywords, tables and figures
